Multi-Million Dollar Settlement for Medical Malpractice

Senior Trial Counsel Mark H. Grimm and Attorneys Tim Lynch and Tom Moran, recently achieved a multi-million-dollar settlement in a medical negligence case involving the tragic death of an infant.

The parents believed that there was a failure to timely and properly treat their child who was in respiratory distress and that, as a result, the child suffered severe brain damage and died thereafter.

Defendants strongly denied liability. However, after an extensive work up through the litigation process, which included depositions of numerous medical providers, research, and preparation of experts in the field, the matter was resolved shortly before what was expected to be a lengthy trial.

SOCIAL SECURITY DISABILITY

Can Social Media Affect Your Disability Benefits?

Can a selfie really be dangerous? If you are on social media and applying for or receiving Social Security Disability benefits, it just might be. The Social Security Administration is working on a plan to check on what disability claimants post on social networks such as Facebook and Twitter. This is the latest tactic in their attempt to crack down on disability fraud. While many fraud protection measures are already in place, current administrators want online presence to be a factor in whether a person is eligible for disability insurance.

The Social Security Administration is already using social media when a fraud investigation is ongoing. They stated in a recent report that since 2018, "Agency adjudicators use social media information to evaluate a beneficiary's symptoms." For now, the agency selectively reviews social media feeds only if investigators suspect someone is fraudulently collecting benefits and they are looking for corroboration. However, the agency has stated that they want to expand the use of social media to include "assessing the consistency and supportability of evidence in a claimant's case file."

How could this affect you? Imagine you receive SSDI benefits for a debilitating back injury. This injury causes you to be in pain every day and doesn't allow you to work. A special occasion arises, and you are asked to go to a golf outing or to attend a sports event. You attend, although in pain, and manage to

participate very briefly in the activity. If you then posted a photo of yourself playing golf or doing physical activity, your benefits may be at risk.

In a recent article by the New York Times, the Social Security Administration is reported to be working on furthering the use of social media to determine disability eligibility. They believe that social media platforms could be a "treasure trove" of information about those applying for or receiving disability. This fails to take into account that disabled people may be able to lead relatively normal lives, or may post old photos, from before they were disabled. Eric Buehlmann, deputy executive director of public policy at the National Disability Rights Network told AARP, "This proposal starts with the discriminatory assumption that people with disabilities do nothing socially in the community, or have lives, so that anything the person does on social media can be classified as some form of fraud." Suppose you post a photo of yourself out with friends or family who are doing a physical activity. Does this mean that you shouldn't receive the disability benefits you need?



HOW TO PREPARE FOR Storms in New England

Summer is finally here, and while that means fun in the sun, it can also bring the threat of dangerous storms. So, it is always a good idea to examine your family emergency plan.

Do you have a communication plan and survival kit for each family member and your pets? Are your important documents saved someplace safe and accessible? What does your insurance cover? If not, or you are not sure, check out our Storm Preparedness Best Practices Checklist. We hope you never have to use your survival kit or insurance, but we'd rather you be ready.



Compile an

INSURANCE GUIDE

- ▷ Take pictures and video of your valuables and possessions prior to the storm's arrival.
- ▷ Review existing policies to understand the extent of your coverage.
- ▷ Earthquake, flood and hurricane insurance is not covered by standard homeowners' insurance.
- ▷ Beware: It can take as long as 30 days before insurance companies pay out.
- ▷ Create a one-page document with insurance policy and account numbers.
- ▷ Store important documents in a safe place such as a safety deposit box and make copies.



Create a FAMILY EMERGENCY & COMMUNICATION PLAN

- ▷ How will you contact each other?
- ▷ Where will you meet for safety in case of evacuation?
- ▷ Where are the closest hospitals?
- ▷ Where is the survival kit?



Prepare a SURVIVAL KIT

with 3-5 days worth of supplies

Medical

- ▷ Medicine (7 day supply)
- ▷ First Aid Kit

Food and Water

- ▷ Water (1 gallon/person/day)
- ▷ Can Opener and Utensils
- ▷ Nonperishable foods
- ▷ Baby food and supplies
- ▷ Pet food and supplies

Sanitation and Hygiene

- ▷ Sanitation and toiletry items
- ▷ Durable, water-resistant portable container

Shelter, Safety and Comfort

- ▷ Blankets and/or sleeping bags
- ▷ Map of area and evacuation route
- ▷ Hand and body warm packs
- ▷ Flashlight and head lamp
- ▷ Extra Clothes/Shoes
- ▷ Smart phone back-up charger
- ▷ Matches
- ▷ Batteries
- ▷ Whistle
- ▷ Weather Radio

Other

- ▷ Cash
- ▷ Important Documents
- ▷ Emergency phone numbers
