# Winter Driving Safety Tips

rom icy roads to poor visibility, winter driving in New England can be challenging.Thankfully, there are precautions that drivers can take to stay safe during these months.

Before getting on the road, it is a good idea to get your vehicle inspected and serviced to decrease the chance of a breakdown. It is especially important to check your tires. The cold temperature can reduce the tire pressure and worn tires will not maintain traction on slippery roads. In addition, keep emergency supplies in your vehicle and try to have at least half a tank of gas at all times to help prevent fuel lines from freezing.

When driving, try to stay on main roads which are more likely to have been properly plowed and leave extra space between the vehicle in front of you to allow time to react without skidding. If your vehicle does skid, turn slightly in the direction your back wheels are sliding. Keep your lights on even during the day to help other motorists see your car through the snow and spray.

In the event of an accident, generally it is advised to stay in your vehicle and use blankets to stay warm. If you decide to run your engine, open the windows at least a crack to prevent carbon monoxide poisoning and clear the area around the exhaust pipe.  $\oplus$
