BACK TO SCHOOL Bus Safety Tips

s summer comes to a close and children return to school, parents are reminded of the dangers children can face on and around school buses. Though traveling via school bus is safer for children than riding in a car, the danger lies in approaching and/or exiting the bus. In a recent report by *School Transportation News*, of the 8,500 to 12,000 children injured in school bus accidents annually, 96% are considered minor (scrapes, bumps, bruises, etc.) with approximately 350 to 475 of these accidents being "serious" (broken bones or worse).

One serious accident being too many, the following safeguards can help parents teach their children how to prevent accidents. Education and repetition being key, here are some helpful ways to remind children (and yourself) to be safe when approaching and/or exiting school busses.

NOTABLE CASE HIGHLIGHTS OF 2012

Some of our recently settled cases include:

- Confidential resolution reached in medical negligence death claim on behalf of family of 20 year-old. Defendants failed to obtain diagnostic testing and neglected to provide proper care in the emergency room. The insurance carrier for the hospital resolved the case after liability was established through litigation and our client's well-credentialed experts were disclosed.
- \$100,000 recovery for two separate bicyclists. Each client received maximum policy limits resulting from a collision with obstacles after motorists negligently entered lane of travel. The Firm continues to pursue underinsured motorist recoveries for both clients
- \$115,000 recovery for the family of a wrongful death victim due to complications of treatment medications from a low-impact automobile accident. The recovery amount was limited by the liability insurance limits available.
- \$100,000 settlement for shoulder injuries sustained in auto accident. Defendant's insurer strenuously defended case on liability and comparative fault basis. Ultimately, after sustained litigation, the policy limit is offered and accepted. The firm is currently pursuing underinsured motorist recovery.
- \$200,000 recovery exhausting defendant's policy limits and underinsured motorist policy limits for auto accident victim who was forced to undergo spinal surgery.

- Have children put all items in a backpack to prevent dropping items along the way;
- Warn children that, if they drop something, they should never pick it up. Instead, they should tell the driver and follow the driver's instructions. If they bend over to pick up a dropped object, they might not be seen by the driver and could be hurt if the driver pulls away from the stop;
- Encourage safety in numbers. If your child is younger, walk them to the bus stop and have older children walk in groups. Larger groups are easier for drivers to see;
- Ensure children completely check for traffic stopping to look left, right and left again if the child must cross the street;
- Teach your children to secure loose drawstrings and other objects that may get caught in the handrail or door of the bus as they are exiting;
- Urge children to leave home on time so they can walk to the bus stop and arrive safely before the bus appears;
- If you meet your child at the bus stop after school, wait on the same side where the child is dropped off, not across the street. Children can be so excited to see you that they dash across the street and forget the safety rules.

As drivers, a few extra seconds of precaution can prevent major accidents. When driving in neighborhoods and school zones, stay alert for young people who may dart into the street without looking. Children can often be distracted and not thinking about safety. Often, careful driving and alertness can be the difference in causing an accident or preventing one.
