

Rhode Island Roads and Their Accidents

ccidents can happen at any time and any place. At Marasco & Nesselbush, we see accidents that have occurred during the day and night, in rural streets and city roads, and with drivers young and old. Although each accident's factors may differ, there are certain streets and intersections within the state that we see more than others.

As we mentioned earlier, accidents can happen at any time. According to the Insurance Institute for Highway Safety (IIHS), on average, there are over 6 million passenger car accidents in the U.S. every year. Road crashes are the leading cause of death in the country, resulting in more than 38,000 people losing their lives each year.

Specifically, in Rhode Island, the accident rate is lower in the state than in the country, and that number continues to decrease. There were 67 fatalities from auto accidents in 2020, which is an increase from 2019, but down from the highest year in the past decade, 2017.

Identifying the most frequent accident locations in Rhode Island can help everyone to be more aware on the road and pay more attention when in these locations and on the road in general. Together, we can bring the number of accidents and fatalities down to zero.

Here are some of the locations with the most accidents:

- Interstate 95 (North and South)
 - The 6/10 Connector
- RI 146 (South) at Interstate 95 (South)
 - RI 146 at Sayles Hill Road
